## HT4200021 Certificate in Safety and Hygiene for Swimming Pool and Spa Managers 泳池及水療機構衛生及安全經理證書



### Programme Objectives | 課程宗旨

The Certificate in Safety and Hygiene for Swimming Pool and Spa Managers is an advanced level programme designed to provide industry practitioners who are working in the swimming pool, spa, clubhouse and related leisure and recreation industry at supervisory level with both theoretical and practical knowledge. This programme is delivered through lectures, group discussions and/or instrument use demonstrations to uplift students' knowledge in managing, controlling, monitoring and assessing the safety and hygiene of the swimming pool and spa facilities.

泳池及水療機構衛生及安全經理證書為一進階課程，內容結合理論和實踐，適合從事泳池、水療、會所或相關康體設施的管理人員修讀；透過課堂講解、小組討論及/或儀器使用示範等授課模式，提升學員對管理、監控、檢視及評估泳池、水療及相關設施的安全衛生。
