# Programme Objectives | 課程宗旨

The Certificate in Safety and Hygiene for Swimming Pool and Spa Managers is an advanced level programme designed to provide industry practitioners who are working in the swimming pool, spa, clubhouse and related leisure and recreation industry at supervisory level with both theoretical and practical knowledge. This programme is delivered through lectures, group discussions and/or instrument use demonstrations to uplift students' knowledge in managing, controlling, monitoring and assessing the safety and hygiene of the swimming pool and spa facilities.
