- One-hour assessment in a form of multiple-choice questions. Upon successful completion of the programme (i.e. attended a minimum of 80% of the classes and passed the assessment), students will be awarded a Certificate of Attainment issued by the Hospitality Discipline of the Vocational Training Council; and
- Eligible to apply for associate member of the Hong Kong Institute of Certified Property Managers
