"The Programme Team Coordinator" should acknowledge receipt of it in writing normally within 5 working days. This will be conducted a further investigation into this appeal. Result of appeal investigation would be responded in writing within 20 working days. 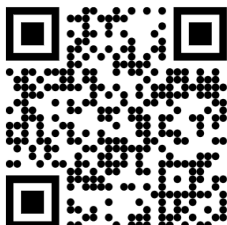
